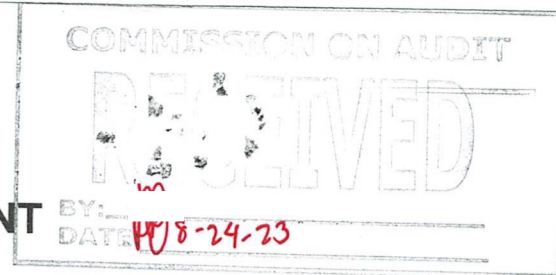

CONTRACT AGREEMENT



THIS AGREEMENT, made this 22nd day of August, 2023 between **Agricultural Training Institute – Regional Training Center I (ATI-RTC I)** represented by **DR. JOSEPHINE K. ABEN** with office address at **Tebag East, Sta. Barbara, Pangasinan** (hereinafter called the "Entity") and **H.G. LOPEZ CONSTRUCTION** represented by **MR. HECTOR G. LOPEZ** with office address at **San Pablo, Balaoan, La Union** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Establishment of Swine Artificial Insemination (AI) sa Barangay with Facilities and Equipment in San Gabriel, La Union** with project number **2023-07-0258** (hereinafter called "the Works") and the Entity has accepted the Bid for **Three Million Three Hundred Forty Seven Thousand Four Hundred Eighty Pesos and Sixty Five Centavos (Php 3,347,480.65)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract. IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.
