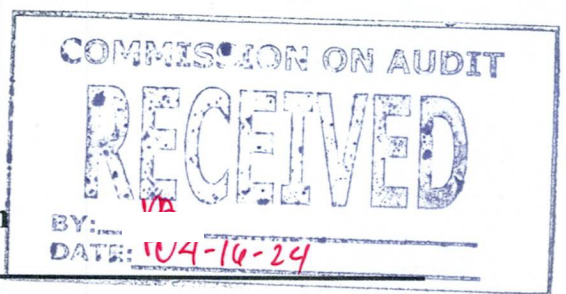

Contract Agreement Form

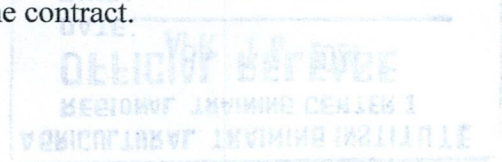
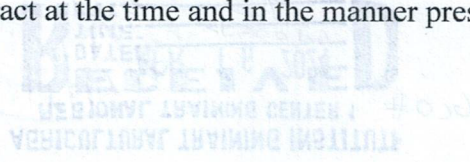


THIS AGREEMENT made on the 15<sup>th</sup> day of April 2024 between AGRICULTURAL TRAINING INSTITUTE - REGIONAL TRAINING CENTER I at Tebag East, Sta. Barbara, Pangasinan, Philippines hereinafter called "the Entity" of the one part and RSB GENERAL MERCHANDISE with business address at Bonuan, Gueset, Dagupan City hereinafter called "the Supplier" of the other part:

WHEREAS the Entity invited Bids for certain goods, viz., *Procurement of Extension Support for 2024 National Urban Agriculture and Peri Urban Agriculture Program of ATI-RTC I with Project No. 2024-03-0070* and has accepted a Bid by the Supplier for the supply of those goods in the sum of **Nine Hundred Thirty-Two Thousand Nine Hundred Eighty Pesos (Php 932,980.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
