

## Contract Agreement Form

---

THIS AGREEMENT made on the 30<sup>th</sup> day of January 2025 between AGRICULTURAL TRAINING INSTITUTE - REGIONAL TRAINING CENTER I at Tebag East, Sta. Barbara, Pangasinan, Philippines hereinafter called "the Entity" of the one part and RANNIAG SECURITY SERVICES INC. with business address at Room 8D, 3F Prime Place Estate, Diversion Road, Panicsican, San Juan, La Union hereinafter called "the Supplier" of the other part:

WHEREAS the Entity invited Bids for certain goods, viz., *Procurement of Security Services for February to December 2025 with Project No. 2025-01-0001* and has accepted a Bid by the Supplier for the security services in the sum of **One Million Six Hundred Fifty-Five Thousand Four Hundred Fifty-Six Pesos and Eighty Eight Centavos (Php 1,655,456.88)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (*e.g.* bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. In the event that the First Party ceases to maintain or occupy the Satellite Station in Tabug, Batac City, Ilocos Norte, the contract for the provision of the three (3) security guards shall be terminated in accordance with the terms and conditions specified in the agreement between the First Party and the security service provider.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
