

A RESOLUTION RECOMMENDING FOR APPROVAL FOR THE AWARD OF CONTRACT

BAC Resolution No.05.174, series of 2024.

Provision of Supplies to be used for the conduct of the Digital Agriculture Course for RCEF at ATI-RTC X, El Salvador City, Misamis Oriental on June 20-22 and July 31-August 2, 2024

WHEREAS, the Head of Procuring Entity (HOPE) of Agricultural Training Institute Regional Training Center X (ATI-RTC X) had approved Purchase Request (P.R.) No. 2024.03.101 for Provision of Supplies to be used for the conduct of the Digital Agriculture Course for RCEF at ATI-RTC X, El Salvador City, Misamis Oriental on June 20-22 and July 31-August 2, 2024 with Approved Budget for the Contract (ABC) **ONE HUNDRED THIRTY-FOUR THOUSAND THREE HUNDRED FIFTY PESOS (P134,350.00)** in accordance to the End-users Project Procurement Management Plan (PPMP);

WHEREAS, to promote transparency and competitiveness, and in compliance to Sec. 10 of Republic Act 9184 (RA 9184) and Sec. 21.1 and 21.2 of its 2016 Revised Implementing Rules and Regulations (2016 Revised IRR), the Request for Quotation was posted to the PhilGEPs Website on May 3-6, 2024 with Reference No. 10813429(1st Posting), and May 7-10, 2024 with Reference No. 10813429(2nd Posting), ATI website on May 2, 2024 and ATI RTC X Bulletin Board on May 3-10, 2024;

WHEREAS, before the lapse of the deadline for the submission of quotation, at 5:00PM, May 10, 2024, **WIZMASTER COMPUTER SALES & SERVICES CORP., SEPTEM CHANDELLING & CONSUMER GOODS TRADING, BMG CONSUMER GOODS TRADING, and DOMINUS I.T COMPUTER TRADING** submitted their quotation;

WHEREAS, upon thorough assessment of the financial proposal submitted **DOMINUS I.T COMPUTER TRADING** in the amount of **ONE HUNDRED THIRTY-FOUR THOUSAND TWO HUNDRED SIXTY PESOS (P134,260.00)** is the lowest calculated quotation;

WHEREAS, upon careful review and evaluation on the legal requirements submitted, it was found that **DOMINUS I.T COMPUTER TRADING** is compliant with the eligibility requirements as evidenced by the submission of its Mayor's/Business Permit and PhilGEPs Registration Number;

WHEREAS, upon evaluation of the quotation for the technical requirements of the project, **DOMINUS I.T COMPUTER TRADING** has been found to be compliant, and, thus, being recommended to be declared as the lowest calculated and responsive quotation for consideration of award of contract;

WHEREAS, the report containing the result of the eligibility screening dated _____ is attached hereto and made an integral part hereof;

1. **Declare DOMINUS I.T COMPUTER TRADING, as the Responsive Bidder Provision of Supplies to be used for the conduct of the Digital Agriculture Course for RCEF at ATI-RTC X, El Salvador City, Misamis Oriental on June 20-22 and July 31-August 2, 2024;**
2. **Recommend to Award and Approve the Contract to DOMINUS I.T COMPUTER TRADING at its submitted bid price amounting ONE HUNDRED THIRTY-FOUR THOUSAND TWO HUNDRED SIXTY PESOS (P134,260.00)**
3. **Recommend for Approval by the Center Director the foregoing findings/recommendations.**


