A RESOLUTION RECOMMENDING FOR APPROVAL FOR THE AWARD OF CONTRACT

BAC Resolution No.09.358, series of 2024.

Provision of Catering services to be served during the conduct of Culminating Activity of the Youth Internship Program in Organic Agriculture (YIPOA) on December 14,2024 in El Salvador City, Misamis Oriental

WHEREAS, the Head of Procuring Entity (HoPE) of Agricultural Training Institute Regional Training Center X (ATI-RTC X) had approved Purchase Request (P.R.) No. 2024.09.279 for **Provision of Catering services to be served during the conduct of Culminating Activity of the Youth Internship Program in Organic Agriculture (YIPOA) on December 14,2024 in El Salvador City, Misamis Oriental** with Approved Budget for the Contract (ABC) **FIFTY THOUSAND FOUR HUNDRED PESOS (₱50,400.00)** in accordance to the End-users Project Procurement Management Plan (PPMP);

WHEREAS, to promote transparency and competitiveness, and in compliance to Sec. 10 of Republic Act 9184 (RA 9184) and Sec. 21.1 and 21.2 of its 2016 Revised Implementing Rules and Regulations (2016 Revised IRR), the Request for Quotation was posted to the PhilGEPS Website on September 13-16, 2024 with Reference No. 11243275(1st Posting), and September 17-20, 2024 with Reference No. 11243315(2nd Posting), ATI website on September 12, 2024, and ATI RTC X Bulletin Board on September 13-20, 2024;

WHEREAS, before the lapse of the deadline for the submission of quotation, at 5:00PM, September 20, 2024, **NMFDC, SIR NAP'S KAMBINGAN AND CATERING SERVICES, and EL SAL ALS MPC** submitted their quotation;

WHEREAS, upon thorough assessment of the financial proposal submitted **SIR NAP'S KAMBINGAN AND CATERING SERVICES** in the amount **FORTY-NINE THOUSAND NINE HUNDRED TWENTY PESOS (₱49,920.00)** is the lowest calculated quotation;

WHEREAS, upon careful review and evaluation on the legal requirements submitted, it was found that **SIR NAP'S KAMBINGAN AND CATERING SERVICES** is compliant with the eligibility requirements as evidenced by the submission of its Mayor's/Business Permit and PhilGEPS Registration Number;

WHEREAS, upon evaluation of the quotation for the technical requirements of the project, **SIR NAP'S KAMBINGAN AND CATERING SERVICES** has been found to be compliant, and, thus, being recommended to be declared as the lowest calculated and responsive quotation for consideration of award of contract;

WHEREAS, the report containing the result of the eligibility screening dated January 8, 2024 is attached hereto and made an integral part hereof;

NOW THEREFORE, in the consideration of the foregoing, **WE, the Members of the Bids and Awards Committee**, by virtue of the powers vested to us by law, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. **Declare SIR NAP'S KAMBINGAN AND CATERING SERVICES, as the Responsive Bidder for Provision of Catering services to be served during the conduct of Culminating Activity of the Youth Internship Program in Organic Agriculture (YIPOA) on December 14,2024 in El Salvador City, Misamis Oriental;**
2. **Recommend to Award and Approve the Contract to SIR NAP'S KAMBINGAN AND CATERING SERVICES at its submitted bid price amounting FORTY-NINE THOUSAND NINE HUNDRED TWENTY PESOS (₱49,920.00);**
3. **Recommend for Approval by the Center Director the foregoing findings/recommendations.**

This resolution shall take effect immediately.
