WHEREAS, the Head of Procuring Entity (HoPE) of Agricultural Training Institute Regional Training Center X (ATI-RTC X) had approved Purchase Request (P.R.) No. 2024.09.292 for Provision of Catering services to be served during the conduct of PALAYHigalaay sa ATI and Culmination Activity in ATI-RTC X, El Salvador City, Misamis Oriental on November 22 and 29, 2024 with Approved Budget for the Contract (ABC) EIGHTY-EIGHT THOUSAND PESOS (\$\mathbf{P}88,000.00) in accordance to the End-users Project Procurement Management Plan (PPMP);

WHEREAS, to promote transparency and competitiveness, and in compliance to Sec. 10 of Republic Act 9184 (RA 9184) and Sec. 21.1 and 21.2 of its 2016 Revised Implementing Rules and Regulations (2016 Revised IRR), the Request for Quotation was posted to the PhilGEPS Website on September 23-26, 2024 with Reference No. 11277931(1ST Posting), and September 27-30, 2024 with Reference No. 11277935(2nd Posting), ATI website on September 22, 2024, and ATI RTC X Bulletin Board on September 23-30, 2024;

WHEREAS, before the lapse of the deadline for the submission of quotation, at 5:00PM, September 30, 2024, NMFDC, SIR NAP'S KAMBINGAN AND CATERING SERVICES, and EL SAL ALS MPC submitted their quotation;

WHEREAS, upon thorough assessment of the financial proposal submitted SIR NAP'S KAMBINGAN AND CATERING SERVICES in the amount EIGHTY-FOUR THOUSAND NINE HUNDRED SEVENTY-FIVE (†84,975.00) is the lowest calculated quotation;

WHEREAS, upon careful review and evaluation on the legal requirements submitted, it was found that SIR NAP'S KAMBINGAN AND CATERING SERVICES is compliant with the eligibility requirements as evidenced by the submission of its Mayor's/Business Permit and PhilGEPS Registration Number;

WHEREAS, upon evaluation of the quotation for the technical requirements of the project, SIR NAP'S KAMBINGAN AND CATERING SERVICES has been found to be compliant, and, thus, being recommended to be declared as the lowest calculated and responsive quotation for consideration of award of contract;

WHEREAS, the report containing the result of the eligibility screening dated <u>Joruany</u> &, 2024 is attached hereto and made an integral part hereof;
