WHEREAS, the Head of Procuring Entity (HoPE) of Agricultural Training Institute Regional Training Center X (ATI-RTC X) had approved Purchase Request (P.R.) No. 2024.09.270 for to be used during the conduct of Learning Site for Agriculture I and Field validations, monitoring, and geotagging under the CFIDP program with Approved Budget for the Contract (ABC) THREE HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED PESOS (#362,500.00) in accordance to the End-users Project Procurement Management Plan (PPMP);

WHEREAS, to promote transparency and competitiveness, and in compliance to Sec. 10 of Republic Act 9184 (RA 9184) and Sec. 21.1 and 21.2 of its 2016 Revised implementing Rules and Regulations (2016 Revised IRR), the Request for Quotation was posted to the PhilGEPS Website on September 6-9, 2024 with Reference No. 11218970(1ST Posting), and September 10-13, 2024 with Reference No. 11219005 (2nd Posting), ATI website on September 5, 2024, and ATI RTC X Bulletin Board on September 6-13, 2024;

WHEREAS, before the lapse of the deadline for the submission of quotation, at 5:00PM, September 13, 2024, REG'S TRAVEL AND TOURS, RJT VAN RENTAL, and J & C CAR RENTAL **SERVICES** submitted their quotation;

WHEREAS, upon thorough assessment of the financial proposal submitted REG'S TRAVEL AND TOURS in the amount THREE HUNDRED FIFTY-NINE THOUSAND THREE HUNDRED PESOS (Php 359,300.00) is the lowest calculated quotation;

WHEREAS, upon careful review and evaluation on the legal requirements submitted, it was found that, REG'S TRAVEL AND TOURS is compliant with the eligibility requirements as evidenced by the submission of its Mayor's/Business Permit and PhilGEPS Registration Number;

WHEREAS, upon evaluation of the quotation for the technical requirements of the project, REG'S TRAVEL AND TOURS has been found to be compliant, and, thus, being recommended to be declared as the lowest calculated and responsive quotation for consideration of award of contract;

WHEREAS, the report containing the result of the eligibility screening dated 9, 2024 is attached hereto and made an integral part hereof;
