WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.

WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: Franco Photoshoppe & Allied Services, Rinografix Printshop Enterprise, and Alba's Copy Center & Office Supplies.

Whereas, upon opening and further evaluation of the Bids and Awards Committee (BAC), it was determined that **Rinografix Printshop Enterprise** was compliant and thus considered to have the lowest calculated and responsive bid.
