WHEREAS, the Information Services Section of the Agricultural Training Institute- RTC 13 submitted a Purchase Request for the provision of advertising services for RCEF and other AF related programs with an Approved Budget for the Contract (ABC) amounting to One Hundred Eight Thousand Pesos (Php 108,000.00) only.

WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.

WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: Father Saturnino Urios University, Northern Mindanao Broadcasting System, Inc., and Grand Watergate Suits Corporation.
