**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO RINOGRAFIX PRINTSHOP ENTERPRISE  
FOR THE PROVISION OF PRINTING SERVICES OF IEC MATERIALS  
Resolution No. 2023 - 05 - 111\_P**

WHEREAS, the Partnership and Accreditation Section of the Agricultural Training Institute-RTC 13 submitted a Purchase Request for the provision of printing services of IEC materials for the Livestock program with an Approved Budget for the Contract (ABC) amounting to Two Hundred Twenty-Four Thousand Pesos (Php 224,000.00) only.

WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.

WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: Magadan General Merchandise, Gilcor Printing Press, Signhead Graphics Advertising, Lifeworks Print Hub, Rinografix Printing Enterprise, and Lasertech Copier Services.

Whereas, upon opening and further evaluation of the Bids and Awards Committee (BAC), it was determined that **Rinografix Printing Enterprise** was compliant and thus considered to have the lowest calculated and responsive bid.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, Ph.D. to award the the provision of printing services of IEC materials for the Livestock program to **Rinografix Printing Enterprise** as the bid was considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government.
