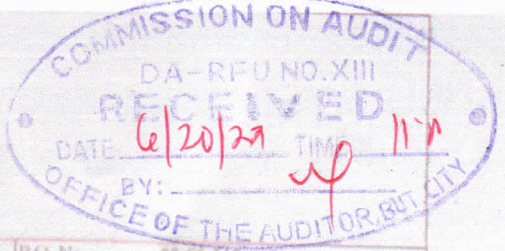

WHEREAS, the Career Development & Management Section of the Agricultural Training Institute-RTC 13 submitted a Purchase Request for the provision of Catering Services for Modified FFS Season-Long on High Quality Inbred Rice on May - August 2023 at Villafranca, Gigaquit, Surigao del Norte with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos (Php 60,000.00) only.

WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.

WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: JMJ Snack Hauz & Catering Services, Gaude Mar Catering Services, & Bites-Avenue Snack Lounge & Catering.

Whereas, upon opening and further evaluation of the Bids and Awards Committee (BAC), it was determined that **Gaude Mar Catering Services** was compliant and thus considered to have the lowest calculated and responsive bid.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, Ph.D. to award the provision of Catering Services for Modified FFS Season-Long on High Quality Inbred Rice on May - August 2023 at Villafranca, Gigaquit, Surigao del Norte to **Gaude Mar Catering Services** as the bid was considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government.
