BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO MONDAYA'S CATERING SERVICES FOR THE PROVISION OF CATERING SERVICES Resolution No. 2023 - 05 - 115_P

WHEREAS, the Career Development and Management Section of the Agricultural Training Institute-RTC 13 submitted a Purchase Request for the provision of catering services for the conduct of Modified FFS Seasonlong Production of High-Quality Inbred Rice & Seeds & Farm Mechanization in Sta. Cruz, Placer, Surigao del Norte on May to August 2023 with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos (Php 60,000.00) only.

WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.

WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: Mondaya's Catering Services, Amarille Eatery, and Amirah Food House.

Whereas, upon opening and further evaluation of the Bids and Awards Committee (BAC), it was determined that Mondaya's Catering Services was compliant and thus considered to have the lowest calculated and responsive bid.
