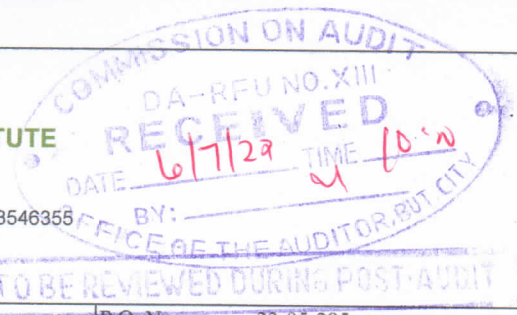

**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO HOMER CATERING SERVICES

Resolution No. 2023 - 05 - 132_P**

WHEREAS, the Career Development & Management Section of the Agricultural Training Institute-RTC 13 submitted a Purchase Request for the provision of catering services for Training on Rice Pests & Diseases for LFTs - 4 Batches on August 8-September 1, 2023 at ATI-RTC 13, Los Angeles, Butuan City with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos (Php 432,000.00) only.

WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.


WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: Bubbly Bake Cakeshop, Jones Catering Services, & Homer Catering Services.


Whereas, upon opening and further evaluation of the Bids and Awards Committee (BAC), it was determined that **Homer Catering Services** was compliant and thus considered to have the lowest calculated and responsive bid.


NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, Ph.D. to award the provision of catering services for Training on Rice Pests & Diseases for LFTs - 4 Batches on August 8-September 1, 2023 to **Homer Catering Services** as the bid was considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government.
