#### **Public Auction Mechanics:**

- 1. The public auction will be conducted in accordance with COA Circular No. 89-296 dated January 27, 1989 and is open to all interested bidders.
- 2. The bid form may be obtained personally from the Inventory and Disposal Committee Secretariat from **August 16 25, 2023** at the Supply Office of ATI-RTC 13, Los Angeles, Butuan City or maybe downloaded through the ATI website at <a href="www.ati.da.gov.ph/ati-13">www.ati.da.gov.ph/ati-13</a>
- 3. All bid proposals shall use the bid form attached as Annex "A." The bid form shall be accomplished in three (3) copies and shall be submitted in a sealed envelope properly addressed at:

- 4. The Bidder must attach along with the bid form the copy of the business license for business entity or Residence Certificate for individuals.
- 5. All bids must be accompanied by a bid bond/s in the form of cash, with an amount equivalent to ten percent (10%) of the bid value of the subject properties to be bid. Such bond shall be refunded to losing bidders after the declaration of the winning bidder.
- 6. All interested bidders may inspect the subject equipment/properties with the assistance of the personnel in charge from August 23-25, 2023 between 9:00 a.m. to 11:00 a.m. and 2:00 p.m. to 4:00 p.m.

- 7. Bid proposals shall be submitted not later than **August 29, 2023 at 2:00 p.m.** through the Inventory and Disposal Committee Secretariat. Late bids shall not be accepted. The opening of bids shall immediately follow at **2:01 p.m.**
- 8. The winning bidder shall be the bid with the highest offered price which shall not be lower than the floor price and the declaration of the winning bidder shall immediately follow
- 9. Should there be a tie in the highest offered price for a particular equipment/properties, the concern bidders shall "draw-lots" to break the tie.
- 10. The winning bidder's bid bond shall automatically be considered as partial payment and the difference between the bid price and the bid bond shall be paid in full to the ATI cashier in the form of cash, cashier's check or manager's check of a reputable bank within five (5) working days from the date of the Notice of Award (NOA). In case of failure of payment of the bid price within the required period, the award shall be cancelled and the bid bond shall be forfeited. The subject equipment/properties shall then be awarded to the next highest bidder.
- 11. The Official Receipt (OR) showing the full payment of the bid price shall be presented to the Administrative Officer which shall serve as the basis for the preparation of the Release Order within five (5) working days upon receipt of the OR.
- 12. The winning bidder is required to take possession of the subject equipment/properties within five (5) working days after receipt of the Release Order, otherwise he shall be charged with daily storage fee in the amount equivalent to one percent (1%) of the floor price of the subject equipment/properties or five hundred pesos (P 500.00) whichever is higher.
- 13. The various unserviceable equipment/properties shall be sold on an "As Is Where Is" basis.
- 14. The bidder shall accept the physical condition and actual state at the time of the public auction of the subject properties. The highest winning bidder shall likewise be responsible for the cost of the transfer of the said properties.
- 15. The Agricultural Training Institute-RTC13 reserves the right to reject any or all bids, or any party thereof, waives any formality, requirements or defects contained therein and will accept the offer it considers most advantageous to the government.
