Contract Agreement Form (Revised)

THIS AGREEMENT made this SEP 28 2023 between **AGRICULTURAL TRAINING INSTITUTE-REGIONAL TRAINING CENTER 13 (ATI-RTC 13)** of Los Angeles, Butuan City, Philippines hereinafter called "the Entity" and **RMB DEVELOPMENT CORPORATION** of Purok 5 B Silad, Mahogany, Butuan City, Agusan del Norte Philippines hereinafter called "the Contractor";

WHEREAS, the Entity is desirous that the Contractor execute **Construction of Single-Storey Bio-secured housing and facilities for Swine AI sa Barangay (SWAIB) project at Sitio Langgam, Barangay Salvacion, San Agustin, Surigao del Sur** hereinafter called "the Works" and the Entity has accepted the Bid for **TWO MILLION SEVEN HUNDRED TEN THOUSAND THREE HUNDRED TWELVE PESOS AND 50/100 (₱ 2,710,312.50)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the


Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWO MILLION SEVEN HUNDRED TEN THOUSAND THREE HUNDRED TWELVE PESOS AND 50/100 (₱ 2,710,312.50)** or such other sums as may be ascertained, **RMB DEVELOPMENT CORPORATION** agrees to **Construct Single-Storey Bio-secured housing and facilities for Swine AI sa Barangay (SWAIB) project at Sitio Langgam, Barangay Salvacion, San Agustin, Surigao del Sur** in accordance with his/her/its Bid.
4. The **AGRICULTURAL TRAINING INSTITUTE-REGIONAL TRAINING CENTER 13 (ATI-RTC 13)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.


