**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO BUTUAN SOUTHVILLE HOTEL & RESTAURANT
FOR THE PROVISION OF CATERING SERVICES FOR FY 2024 OPERATIONAL PLANNING WORKSHOP

WHEREAS, the Planning, Monitoring & Evaluation Unit of the Agricultural Training Institute-RTC 13 submitted a Purchase Request for the provision of Catering Services for FY 2024 Operational Planning Workshop on January 17-19, 2024 at ATI-RTC 13, Los Angeles, Butuan City with an Approved Budget for the Contract (ABC) amounting to One Hundred Twenty-Seven Thousand Five Hundred Pesos (Php 127,500.00) only.

WHEREAS, the Admin-Supply had prepared and facilitated the completion of the Request for Quotation.

WHEREAS, after sending RFQs to suppliers/service providers, the following submitted their quotations: Flavorful Catering Services, Butuan Southville Hotel & Restaurant, RGS Green Harvest Corporation, Bubbly Babe Cakeshop, & Homer Catering Services.

Whereas, upon opening and further evaluation of the Bids and Awards Committee (BAC), it was determined that **Butuan Southville Hotel & Restaurant** was compliant and thus considered to have the lowest calculated and responsive bid.


NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, Ph.D. to award the provision of Catering Services for FY 2024 Operational Planning Workshop on January 17-19, 2024 at ATI-RTC 13, Los Angeles, Butuan City to **Butuan Southville Hotel & Restaurant** as the bid was considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government.

RESOLVED, this 2nd day of January 2024 at Butuan City, Philippines.


