BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT -SMALL VALUE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF AGRICULTURAL TOOLS AND AWARD OF CONTRACT TO RMS TRADING Resolution No. 2024 - 02- 035

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184:

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure Agricultural Tools for HVCDP trainings and activities with an Approved Budget for the Contract (ABC) amounting to Eighty Thousand Pesos (Php 80,000.00) in accordance with the Agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotations and evaluation of the bids submitted by Pacifica Agrivet Supplies, Inc., Magadan General Merchandise, RMS Trading, Mag-uuma Agri & Poultry Supply, CASS Agricultural Company, and Genesys Enterprises, it was determined that RMS Trading, has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that RMS Trading has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the supply and delivery of Agricultural Tools for HVCDP trainings and activities to RMS Trading as the offer is considered most advantageous to the government.
