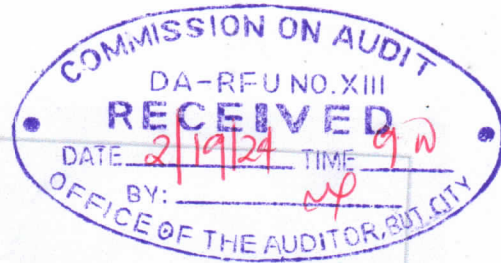

SMALL VALUE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ADVOCACY POLO SHIRT AND
AWARD OF CONTRACT TO CEBOOM ENTERPRISES**
Resolution No. 2024 - 02- 04

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure 135 advocacy polo shirts for PAFES trainings and activities with an Approved Budget for the Contract (ABC) amounting to Sixty-Seven Five Hundred Thousand Pesos (Php 67,500.00) in accordance with the Agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotations and evaluation of the bids submitted by Aptex Textile and Printing Corporation, Avecilla Trading, Seaweed International Exports, Genesys Enterprises, Ceboom Enterprises, Karaga Fashion Center, Axl Sport Apparel Trading, and BSU Prints & Garments, it was determined that by **Ceboom Enterprises**, has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that **Ceboom Enterprises** has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, *THEREFORE* in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the supply and delivery of 135 advocacy polo shirts for PAFES trainings and activities to **Ceboom Enterprises** as the offer is considered most advantageous to the government.
