BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT SMALL VALUE PROCUREMENT FOR <u>CATERING SERVICES FOR TRAINING ON FINANCIAL AND</u> <u>MARKETING STRATEGIES FOR RBOs</u> AND AWARD OF CONTRACT TO <u>RTR CONSUMERS COOPERATIVE</u>

Resolution No. 2024 - 02-

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184:

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure catering services for training on financial and marketing strategies for RBOs with an Approved Budget for the Contract (ABC) amounting to one hundred thirteen thousand seven hundred fifty pesos only (Php 113,750.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of <u>RTR Consumers Cooperative</u>, <u>Bubbly Babe Cakeshop</u>, <u>Homer Catering Services</u>, <u>Butuan Southville Hotel & Restaurant and VCDU Prince Hotel</u>, <u>Inc</u> it was determined that <u>RTR Consumers Cooperative</u> has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that **RTR Consumers Cooperative** has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the catering services for training on financial and marketing strategies for RBOs to **RTR Consumers Cooperative** as the offer is considered most advantageous to the government.
