BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT SMALL VALUE PROCUREMENT FOR VARIOUS ADVOCACY MATERIALS AND AWARD OF CONTRACT TO BSU PRINTS & GARMENTS Resolution No. 2024 - 02-

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure various advocacy materials for the 2 batches of TOT on Corn Production and Management with an Approved Budget for the Contract (ABC) amounting to Ninety-Eight Thousand Pesos (Php 98,000.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of the Avecilla Trading, Mahaneh Garments, Brightsky Non-Specialized Wholesale Trading, and BSU Prints & Garments, the Bids and Awards Committee (BAC) determines that **BSU Prints & Garments** has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that BSU Prints & Garments has the Lowest Calculated and Responsive Bid, thus eligible for award.
