BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT SMALL VALUE PROCUREMENT FOR CHICKEN (LAY PULLETS) AND AWARD OF CONTRACT TO LUCKY SIX POULTRY FARM Resolution No. 2024 - 03 -

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184:

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure 192 heads Chicken (Lay Pullets) for FFARMS egg production project with an Approved Budget for the Contract (ABC) amounting to Eighty-Two Thousand Five Hundred Pesos (Php 82,560.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of the Lucky Six Poultry, Pacifica Agrivet Supplies, Inc., and NJ Agrivet & Garden Supply the Bids and Awards Committee (BAC) determines that **Lucky Six Poultry** has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that **Lucky Six Poultry** has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the supply and delivery of 192 heads Chicken (Lay Pullets) for FFARMS egg production project to **Lucky Six Poultry** as the offer is considered most advantageous to the government.
