## BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT -SMALL VALUE PROCUREMENT FOR CATERING SERVICES AND AWARD OF CONTRACT TO RTR CONSUMERS COOPERATIVE Resolution No. 2024 - 03- 146

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure the Catering Services for TOT on Production of High-Quality Inbred Rice and Seeds and Farm Mechanization under RCEF on April 8-19, 2024 at ATI-RTC 13, Los Angeles, Butuan City with an Approved Budget for the Contract (ABC) amounting to Four Hundred Sixty-Two Thousand Pesos (Php 462,000.00) in accordance with the agency's Annual Procurement-Plan.

Whereas, upon completion of the Request for Quotation of the Bubbly Babe Cakeshop, Butuan Southville Hotel & Restaurant, RTR Consumers Cooperative, and Homer Catering Services, the Bids and Awards Committee (BAC) determines that RTR Consumers Cooperative has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that RTR Consumers Cooperative has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the provision of Catering Services for TOT on Production of High-Quality Inbred Rice and Seeds and Farm Mechanization under RCEF on April 8-19, 2024 at ATI-RTC 13, Los Angeles, Butuan City to RTR Consumers Cooperative as the offer is considered most advantageous to the government.
