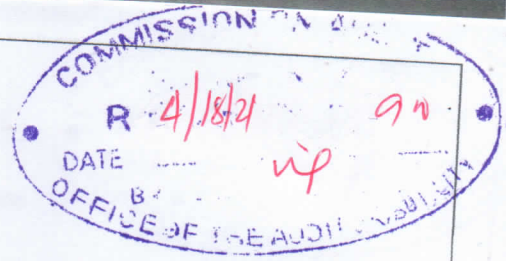

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure various agricultural supplies and materials for the Training on Vegetable Production & Management for Urban & Peri-Urban with an Approved Budget for the Contract (ABC) amounting to One Hundred Fifty-Three Thousand Five Hundred Pesos (Php 153,500.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of the RMS Trading, Caraga General Merchandise & Enterprise Corp., Good Soil Agrivet Supply, and Mag-uuma Agri & Poultry Supply, the Bids and Awards Committee (BAC) determines that **Good Soil Agrivet Supply** has the Lowest Calculated Bid.


