## BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT -SMALL VALUE PROCUREMENT FOR TRANSPORTATIONS SERVICES AND AWARD OF CONTRACT TO CARAGA TRANSPORT SERVICE COOPERATIVE Resolution No. 2024 - 04 - 4

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184:

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure the provision of transportation services (van rental) during the conduct of CFIDP training and activities from the period of April to August 2024 within the region with an Approved Budget for the Contract (ABC) amounting to Three Hundred Thirty-One Thousand Five Hundred Pesos (Php 331,500.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of the Caraga Transport Service Cooperative, Dada Transport Service, and Neilab'z Express, the Bids and Awards Committee (BAC) determines that Caraga **Transport Service Cooperative** has the Lowest Calculated Bid.

Whereas, upon further evaluation and post-qualification of the BAC, it was determined that Caraga Transport Service Cooperative has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, THEREFORE in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the provision of transportation services (van rental) during the conduct of CFIDP training and activities from the period of April to August 2024 within the region to Caraga Transport Service Cooperative as the offer is considered most advantageous to the government.
