Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure ICT equipment as LSA enhancement support to DOFFAS under RCEF with an Approved Budget for the Contract (ABC) amounting to One Hundred Eight Thousand Five Hundred Pesos (Php 108,500.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of the Power On Enterprises Co., Columbia Computer Center, Inc., Datalan Communication Services, and Fast Tech Computer Parts & Accessories Shop, the Bids and Awards Committee (BAC) determines that **Columbia Computer Center, Inc.** has the Lowest Calculated Bid.


