**BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT -  
SMALL VALUE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ADVOCACY MATERIALS AND  
AWARD OF CONTRACT TO BSU PRINTS & GARMENTS  
Resolution No. 2024 - 05 - 273**

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure 125 pieces Advocacy Jackets for Livestock training and activities with an Approved Budget for the Contract (ABC) amounting to One Hundred Seventy-Five Thousand pesos (Php 175,000.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of Seaweed International Exports, Inc., Corevisory Enterprises Co., Mahaneh Garments, The Potter's House by Chinyu, and BSU Prints & Garments, the Bids and Awards Committee (BAC) determines that **BSU Prints & Garments** has the Lowest Calculated Bids.


Whereas, upon further evaluation and post-qualification of the BAC, it was determined that **BSU Prints & Garments** has the Lowest Calculated and Responsive Bid, thus eligible for award.


NOW, THEREFORE to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the supply and delivery of 125 pieces Advocacy Jackets for Livestock training and activities to **BSU Prints & Garments**, as the offer is considered most advantageous to the government.

Done this 9<sup>th</sup> day of May 2024, at the Agricultural Training Institute-Regional Training Center 13, Los Angeles, Butuan City.


