BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO STRAWHATS PRINTING AND DESIGN FOR THE SUPPLY AND DELIVERY OF ADVOCACY MATERIALS

Resolution No. 2024-05- 264

WHEREAS, the Agricultural Training Institute-RTC 13 published an Invitation to Bid at PhilGEPS website last April 9, 2024 and posted the same on the bulletin board and website of this office for the Supply and Delivery of Advocacy Materials with ID No. ATI-RTC13-G-2024-01 with an Approved Budget for the Contract (ABC) of Five Million Three Hundred Fifty Thousand Two Hundred Fifty Pesos only (Php 5,350,250.00);

WHEREAS, the opening of bids was held on April 30, 2024, at the Balangay Hall, ATI-RTC 13, Los Angeles, Butuan City as scheduled, with four participating bidders namely Aptex Textile Printing Corporation, Magsige MPC, Seaweed International Exports, Inc., and Strawhats Printing and Design.

WHEREAS, upon the opening of bids on the scheduled time, date, and place by the Bids and Award Committee (BAC), the bid proposal submitted by Strawhats Printing and Design amounting to Two Million Six Hundred Seventy Thousand Nine Hundred Forty-Nine Pesos and Two Cents (Php 2,670,949.02) was declared as the Lowest Bid as Read.

WHEREAS, upon detailed evaluation, the Technical Working Group (TWG) noted an arithmetical correction of the bid offered, with the Lowest Calculated Bid as corrected amounting to 2,671,003.25.

WHEREAS, after post-qualification of the BAC, TWG, and end-user on May 6, 2024, the bid submitted by Strawhats Printing and Design was declared as the Lowest Calculated and Responsive Bid, as per the Post Qualification report submitted.


WHEREAS, upon further evaluation and deliberation, the BAC declared that **Strawhats Printing and Design** is eligible for award.


NOW, THEREFORE, to promote economy and efficiency, the BAC hereby recommends to the Head of Procuring Entity (HOPE) OIC-Center Director, **JESSIE V. BELDIA, Ph.D**, to award the Supply and Delivery of Advocacy Materials to **Strawhats Printing and Design** with bid offer amounting to Php 2,670,949.02 as the bid was considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government.


