**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO JELAI & TWIN STORE FOR THE PROVISION OF CATERING SERVICES FOR CENTER-BASED TRAININGS FOR THE MONTHS OF MAY TO SEPTEMBER 2024**

**Resolution No. 2024-05- 231**

**WHEREAS**, the Agricultural Training Institute-RTC 13 published an Invitation to Bid at PhilGEPS website last April 9, 2024 and posted the same on the bulletin board and website of this office for the Provision of Catering Services for Center-based Trainings for the months of May to September 2024 with ID No. ATI-RTC13-G-2024-02 with an Approved Budget for the Contract (ABC) of Two Million One Hundred Thirty-Two Thousand Five Hundred Pesos only (Php 2,132,500.00);

**WHEREAS**, the opening of bids was held on April 30, 2024, at the Balangay Hall, ATI-RTC 13, Los Angeles, Butuan City as scheduled, with two participating bidders namely Homer Catering Services, and Jelai and Twin Store;

**WHEREAS**, upon the opening of bids on the scheduled time, date, and place by the Bids and Award Committee (BAC), the bid proposal submitted by Jelai & Twin Store amounting to Two Million One Hundred Twenty-Two Thousand One Hundred Pesos (Php 2,122,100.00) was declared as the Lowest Bid as Read.

**WHEREAS**, upon detailed evaluation and post-qualification of the BAC, Technical Working Group (TWG), and end-user, the bid submitted by Jelai & Twin Store was declared as the Lowest Calculated and Responsive Bid, as per the Post Qualification report submitted.


**WHEREAS**, upon further evaluation and deliberation, the BAC declared that **Jelai & Twin Store** is eligible for award.


