BAC RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING THE NEGOTIATED PROCUREMENT -SMALL VALUE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ADVOCACY MATERIALS AND AWARD OF CONTRACT TO MAGADAN GENERAL MERCHANDISE Resolution No. 2024 - 05 - 248

Whereas, for the purposes of economy and efficiency in all aspects of government procurement, the ATI-Regional Training Center 13, as approved by the Head of the Procuring Entity resorts to the Alternative Mode of Procurement consistent with the Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184:

WHEREAS, the of the Agricultural Training Institute - RTC 13 intends to procure advocacy materials particularly 20 pieces Luggage Travel Bags as token for Resource Persons for various training and activities under the Rice Program with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos (Php 60,000.00) in accordance with the agency's Annual Procurement Plan.

Whereas, upon completion of the Request for Quotation of The Potter's House by Chinyu, Magadan General Merchandise, and Mayon Shoppers Lifestyle Corporation, the Bids and Awards Committee (BAC) determines that Mayon Shoppers Lifestyle Corporation has the Lowest Calculated Bid, however it offers Cash on Delivery basis payment term.

Whereas, as a general rule, no advance payment, or any payment made prior to the delivery and acceptance of goods, shall be made to any supplier/manufacturer/distributor.

Whereas, the BAC then evaluated the second lowest bidder, and determined that Magadan General Merchandise has the Lowest Calculated and Responsive Bid, thus eligible for award.

NOW, THEREFORE to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity (HOPE), OIC-Center Director JESSIE V. BELDIA, PhD, to award the supply and delivery of advocacy materials particularly 20 pieces Luggage Travel Bags as token for Resource Persons for various training and activities under the Rice Program to Magadan General Merchandise, as the offer is considered most advantageous to the government.
