This RENEWAL OF CONTRACT made and entered into by and between the following:

AGRICULTURAL TRAINING INSTITUTE-REGIONAL TRAINING CENTER 13 (ATI-RTC 13), the training and extension arm of the Department of Agriculture, with office address at Los Angeles, Butuan City, represented herein by its **OIC-Center Director, NOEMI BETH G. MACARIO, CESE**, hereinafter called the "CLIENT."

LIFEWORCS PRINTHUB, tarpaulin printing services provider, with office address at J. Flores Avenue, Butuan City, represented herein by its Supervisor, **MR. RUSBERT O. OLAYON** hereinafter called the "AGENCY."

Collectively, the "**PARTIES**,"

WITNESSETH:

WHEREAS, the PARTIES entered into a Contract Agreement which was in force and effect from January 1, 2024 until December 31, 2024. A copy if the said Original Contract is attached as "ANNEX A' and made an integral part of this Agreement;

WHEREAS, the renewal of the Contract for the Tarpaulin Printing is necessary for the conduct of trainings and other activities. The period of renewal is from January 1, 2025 to December 31, 2025.

WHEREAS, the guidelines on the renewal of regular and recurring services provides that the Procuring Entity may renew the contract not to exceed (1) year, provided it complies with the conditions stated therein;

WHEREAS the Head of the Procuring Entity (HoPE) approved the Bids and Awards Committee (BAC) Resolution Number 2024-12-11, recommending the renewal of the contract for the Tarpaulin Printing from January 1, 2025 to December 31, 2025, with a contract amount of **Twelve Pesos Only (₱12.00) per square foot of tarpaulin on staggered basis upon request** under Purchase Request No. 24-12-852.

NOW, THEREFORE, the PARTIES hereby agree as follows:

1. The terms and conditions of the Original Contract shall be read and construed as part of this Agreement, and all terms and conditions of the Original Contract which are consistent with this Agreement shall remain unchanged and in full force and effect.

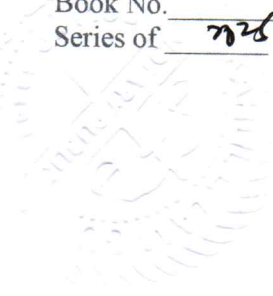
