## RENEWAL OF CONTRACT

### PROVISION OF SECURITY SERVICES FOR FY 2025

This RENEWAL OF CONTRACT made and entered into by and between the following:

**AGRICULTURAL TRAINING INSTITUTE-REGIONAL TRAINING CENTER XIII (ATI-RTC XIII)**, the training and extension arm of the Department of Agriculture, with office address at Los Angeles, Butuan City, represented herein by its **OIC-Center Director, NOEMI BETH G. MACARIO, CESE**, hereinafter called the "CLIENT."

- and -

**SHERLOCK SECURITY AGENCY**, security services provider, with office address at the 2<sup>nd</sup> Floor Laurente Building, AD Curato St., Butuan City, represented herein by its Area Supervisor, **MR. RICKY C. TABASA** hereinafter called the "AGENCY."

Collectively, the "**PARTIES**,"

WITNESSETH:

**WHEREAS**, the PARTIES entered into a Contract Agreement which was in force and effect from January 1, 2024 until December 31, 2024. A copy if the said Original Contract is attached as "ANNEX A' and made an integral part f this Agreement;

**WHEREAS**, the renewal of the Contract for the provision of security services is necessary for the continued protection and safety of the CLIENT facilities, equipment, and employees. The period of renewal is from January 1, 2025 to December 31, 2025.

**WHEREAS**, the guidelines on the renewal of regular and recurring services provides that the Procuring Entity may renew the contract not to exceed (1) year, provided it complies with the conditions stated therein;

**WHEREAS** the Head of the Procuring Entity (HoPE) approved the Bids and Awards Committee (BAC) Resolution Number 2024-12-09, recommending the renewal of the contract for the Provision of Security Services from January 1, 2025 to December 31, 2025, with a total contract amount of **Four Hundred Forty-One Thousand One Hundred Thirty and 08/100 Pesos Only (P441,130.08)** under Purchase Request No. 24-12-850.

**NOW, THEREFORE**, the PARTIES hereby agree as follows:

1. The terms and conditions of the Original Contract shall be read and construed as part of this Agreement, and all terms and conditions of the Original Contract which are consistent with this Agreement shall remain unchanged and in full force and effect.
2. The PARTIES agree to renew the Contract for the additional period which shall begin immediately upon the expiration of the Original Contract, or from January 1, 2025 to December 31, 2025.




