**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG DETAILED BID EVALUATION  
REPORT AND DECLARING THE LOWEST CALCULATED BID (SCB) AND RECOMMENDING  
FURTHER POST-QUALIFICATION**

**BAC Resolution No. PB-01 s. 2023**

**WHEREAS**, the Agricultural Training Institute – Regional Training Center III intends to procure for the **PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF SEASON LONG TRAINING OF TRAINERS (SL-TOT) ON INTEGRATED CROP MANAGEMENT FOR CORN LEADING TO NATIONAL COMPETENCY (NC) III (UNDER CORN PROGRAM) IN PALAYAN CITY, NUEVA ECIJA** with Identification Number: ATI-RTC3-2023PB-001, PhilGEPS Reference Number: 9388480 under Corn Program with an Approved Budget of the Contract (ABC) of **ONE MILLION EIGHT HUNDRED NINETY-NINE THOUSAND SIX HUNDRED PESOS ONLY (PHP 1,899,600.00)**;

**WHEREAS**, Section 10 Rule IV of the IRR-A of the RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

**WHEREAS**, on January 6, 2023, an Invitation to Bid for the procurement of the above-mentioned project was posted on PhilGEPS Website (9388480), ATI RTC III Website (<https://ati2.da.gov.ph/ati-3/content/bids/thu-01052023-1406/invitation-bid-procurement-catering-conduct-season-long-training-trainers-sl>), and Center's Bulletin Board;

**WHEREAS**, in response to the said advertisements, (3) Prospective Bidder <sup>1</sup> **ANTHONY'S RESTAURANT** <sup>2</sup> **ROQ UNIVERSITY BUSINESS CENTER** <sup>3</sup> **LAI CATERING SERVICES** acquired Bidding Documents upon presentation of their Letter of Intent;

**WHEREAS**, Pre-Bid Conference was held on January 16, 2023 at 9:00 AM;

**WHEREAS**, Bid Bulletin No. 1, published on January 16, 2023, updating the schedule of trainings;

**WHEREAS**, on January 30, 2023 at 10:00am, during the Submission and Opening of Bid, the BAC received only three (3) bidder, namely, <sup>1</sup> **ANTHONY'S RESTAURANT** <sup>2</sup> **ROQ UNIVERSITY BUSINESS CENTER** <sup>3</sup> **LAI CATERING SERVICES**, and participated with One (1) Observer;

**WHEREAS**, below is the result of the opening and evaluation of its financial proposal:


**NOW THEREFORE**, We the Members of the Bids and Awards Committee hereby **RESOLVE**:


