**INVITATION TO BID FOR
CONSTRUCTION OF SINGLE-STOREY (BOAR STUDIO) FOR SWINE AI SA BARANGAY (SWAIB)
PROJECT AT BRGY. PUTIAO, PILAR, SORSOGON**

The Agricultural Training Institute (ATI), through the 2021 General Appropriations Act, intends to apply the sum of **Two Million Five Hundred Five Thousand Pesos (PhP 2,505,000.00)** being the Approved Budget for the Contract (ABC) to payments under the Contract for the Construction of the **Single-Storey (Boar Studio) for Swine AI sa Barangay (SWAIB) Project at Brgy. Putiao, Pilar, Sorsogon**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The ATI now invites for the said contract/project. Completion of the Works is required **Forty-Five (45) calendar days upon issuance of Notice to Proceed**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II: Instruction to Bidders. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of One Thousand Pesos (PhP 1,000.00) to the ATI-RTC 5 Cashier. The method of payment shall be in cash. Bid documents could be received personally by the prospective bidder or his representative upon showing the copy of the Official Receipt issued by the ATI-RTC 5 Cashier to the BAC Secretariat.


The ATI-RTC 5 shall hold a Pre-Bid Conference on **October 13, 2022, 1:00 p.m. at the Calaguas Hall, ATI-RTC 5, San Agustin, Pili, Cam. Sur**.

Bids must be submitted to the address below on or before **August 30, 2022 12:00 NN at the ATI-RTC 5, San Agustin, Pili, Cam. Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids shall be opened at 1:00 p.m. on the same date and venue. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The ATI-RTC 5 reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
