- Sealed proposals/quotations should be submitted in duplicate copies using this Official Request for Quotation Form.
   Sealed quotation shall be submitted to BAC Head Secretariat at Agricultural Training Institute-Regional Training Center VI, ASU Compound, Banga, Aklan or through email address at ati6.bac@gmail.com.
- Quotation through email should be9ar the signature of the supplier and shall be addressed to the Head Secretariat of BAC, Ms. Dianne D. Rivera.
- 6. Quotations through fax are allowed for all suppliers **outside Aklan only**.
- 7. Late submission of sealed quotation shall not be accepted.
- 8. Quotations exceeds the Approved Budget of Contract shall be disqualified.
- 9. Any quotation/offer other than those required and stated in this form shall not be considered for evaluation.
- 10. Quotations must specify any and all kinds of applicable taxes including delivery and other charges that the supplier required.
- 11. Price quotations are valid THIRTY (30) calendar days from the declaration of winning supplier.
