- 4. Sealed quotation shall be submitted to BAC Head Secretariat at Agricultural Training Institute-Regional Training Center VI, ASU Compound, Banga, Aklan or through email address at ati6.bac@gmail.com.
- 5. Quotation through email should be 9ar the signature of the supplier and shall be addressed to the Head Secretariat of BAC, Ms. Dianne D. Rivera.
- 6. Quotations through fax/email are allowed for all suppliers **outside Aklan only**.
