A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHOD OF PROCUREMENT - NEGOTIATED PROCUREMENT: SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES

Section 53.6 and Item V, Letter D, No. 6 of Annex "H" A of 2016 Revised IRR of RA 9184

- **WHEREAS**, as a general rule, all procurements shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;
- **WHEREAS**, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

**WHEREAS,** Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing

Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, under Section 53 (Negotiated Procurement), Item No. 53.6 (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) allows procurement of goods, infrastructure project, and consulting services that can be contracted to a particular supplier, contractor or consultant and as determined by HOPE, which includes Media Services, among others, that covers media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

**WHEREAS**, the ATI RTC-7 prepared a Purchase Request with No. 2023-07-585 for the Drone Services and Fertilizer Inputs with Inclusions: Drone Fertilizer Broadcasting of up to 70 kilos per hectare, 40 kilos per flight with a minimum of 10 hectares per dispatch and muriate potash 0-0-6 application for 8 hectare with 70 kilos per hectare and 11 bags x 50 kilo bags with an Approved Budget for the Contract (ABC) of Seventy-Eight Thousand Five Hundred Pesos Only (Php 78,500.00), in accordance with its PPMP;

WHEREAS, the end-user justifies based on their market study/research that procurement of Media

**Services** which include documentation and airing through negotiated procurement under Section 53.6 is more efficient, economical and advantages of the government;

**NOW THEREFORE**, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, *hereby RESOLVE AS IT HEREBY RESOLVED* to:
