BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF UBAY AGRIVET SUPPLY AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF LAMPAS/LAGARAW FOR THE SOA CFIDP GRADUATION THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of Lampas/Lagaraw for the SOA CFIDP Graduation in the amount allocation of **TWO HUNDRED TWENTY-FIVE THOUSAND PESOS ONLY (P 225,000.00)**, dated August 25,2023 under PR No. 2023-08-687;

WHEREAS, in accrodance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on August 30,2023 under PhilGEPS Ref.No. **10080158**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. MGES GENERAL MERCHANDISE, 2. UBAY AGRIVET SUPPLY sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 05 September 2023. During the opening of the bid proposal and upon checking of the documentary requirements, MGES GENERAL MERCHANDISE and UBAY AGRIVET SUPPLY were declared "**eligible**" to participate in the bidding and thus rated as "**passed**";

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that MGES GENERAL MERCHANDISE, the Lowest Calculated Bidder, is from Cebu City. It was indicated from the PhilGeps posting that the end-user prefers Bohol based suppliers. Thus, the BAC did not accept MGES GENERAL MERCHANDISE's quotation.;

WHEREAS, the TWG conducted another careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations to the second Lowest Calculated Bidder which is the UBAY AGRIVET SUPPLY. It was found out by the TWG that the bid proposal/ quotation submitted by UBAY AGRIVET SUPPLY has been found to be "Responsive";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **UBAY AGRIVET SUPPLY** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **UBAY AGRIVET SUPPLY** as the Lowest Calculated and Responsive Bidder with a bid amounting to **TWO HUNDRED THOUSAND PESOS ONLY (Php 200,000.00)** for the procurement of Lampas/Lagaraw for the SOA CFIDP Graduation;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
