- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Seventy-Four Thousand Six Hundred Thirty-Five Pesos Only (Php 74,635.00) or such other sums as may be ascertained, Thinking Tools Incorporated agrees to PROCUREMENT OF ICT EQUIPMENTS AND ACCESSORIES FOR THE LIPCRADE OF ATL 7 ADMIN



4. The **Agricultural Training Institute – Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
