BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF CEBU BUSINESS HOTEL AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF FOOD AND ACCOMMODATION FOR THE FOR CY 2023 PAFES REVIEW OF PHYSICAL ACCOMPLISHMENT AND REPRIORITIZATION OF PROVINCIAL COMMODITIES THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the provision of food and accommodation for the for CY 2023 PAFES Review of Physical Accomplishment and Reprioritization of Provincial Commodities in the amount allocation of **ONE HUNDRED TWENTY THOUSAND ONE HUNDRED FIFTY PESOS ONLY (P 120,150.00)**, dated September 14,2023 under PR No. 2023-09-741;

WHEREAS, in accrodance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on September 15,2022 under PhilGEPS Ref.No. **10134518**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. CEBU BUSINESS HOTEL, 2. EASTLAND HOTEL AND RESIDENCES, 3. ONE CENTRAL HOTEL AND SUITES CORP. sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 20 September 2023. During the opening of the bid proposal and upon checking of the documentary requirements, CEBU BUSINESS HOTEL, EASTLAND HOTEL AND RESIDENCES and ONE CENTRAL HOTEL AND SUITES CORP. were declared "**eligible**" to participate in the bidding and thus rated as "**passed**" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by WELLDONE EATERY has been found to be "Responsive";

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **CEBU BUSINESS HOTEL** as the Lowest Calculated and Responsive Bidder with a bid amounting to **NINETY-EIGHT THOUSAND SIX HUNDRED FIFTY PESOS ONLY (Php 98,650.00)** for the provision of food and accommodation for the for CY 2023 PAFES Review of Physical Accomplishment and Reprioritization of Provincial Commodities;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
