BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF JUMARY'S HARDWARE AND CONSTRUCTION SUPPLY AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF ESTABLISHMENT OF GREENHOUSE STRUCTURE IN SUPPORT TO URBAN AND PER-URBAN COMMUNITY GARDEN IN BOHOL THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 36 and Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, Section 36. A Single Calculated and Responsive Bid (SCRB) or a Single Rated and Responsive Bid (SRRB) shall be considered for award if it falls under any of the following circumstances:

- a) If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;*
- b) If after advertisement, more than one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or*
- c) If after the eligibility check, more than one bidder meets the eligibility requirements, but only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.*

In all instances, the Procuring Entity shall ensure that the ABC reflects the most advantageous prevailing price for the Government.

WHEREAS, ATI- RTC 7 requested quotation for the provision of Establishment of Greenhouse Structure in support to Urban and Per-Urban Community Garden in Bohol in the amount allocation of **TWO HUNDRED FIFTY THOUSAND PESOS ONLY (P 250,000.00)**, dated June 5,2023 under PR No. 2023-06-415;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPs) for online registered bidders on June 7,2023 under PhilGEPs Ref.No. **9826728**, and ATI 7 website, reposted under bid bulletin no. 9826728 -01 and 9826728-02;

WHEREAS, the procurement team facilitated the invitation of potential bidders and sent 3 sets of Request for Quotation;

WHEREAS, in response to the said invitation, **JUMARY'S HARDWARE AND CONSTRUCTION SUPPLY** sent their quotation through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 04 October 2023. During the opening of the bid proposal and upon checking of the documentary requirements, **JUMARY'S HARDWARE AND CONSTRUCTION SUPPLY** was declared "**eligible**" to participate in the bidding and thus rated as "**passed**" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **JUMARY'S HARDWARE AND CONSTRUCTION SUPPLY** has been found to be "**Responsive**";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **JUMARY'S HARDWARE AND CONSTRUCTION SUPPLY** as the Single Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **JUMARY'S HARDWARE AND CONSTRUCTION SUPPLY** as the Single Calculated and Responsive Bidder with a bid amounting to **Two Hundred Fifty Thousand Pesos Only (Php 250,000.00)** for the provision of Establishment of Greenhouse Structure in support to Urban and Per-Urban Community Garden in Bohol;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
