BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF GILCOR PRINTING PRESS AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF PRINTING AND DELIVERY OF WALL CALENDAR WITH METAL HANGER HOOK THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the provision of printing and delivery of wall calendar with metal hanger hook in the amount allocation of **ONE HUNDRED FIFTY THOUSAND PESOS ONLY (P 150,000.00)**, dated September 12,2023 under PR No. 2023-09-730;

WHEREAS, in accrodance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on September 13,2022 under PhilGEPS Ref.No. **10124875**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. AG3 COLORS PRINTING PRESS, 2. GILCOR PRINTING PRESSL, 3. LARAWAN STUDIO OFFSET PRESS sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 20 September 2023. During the opening of the bid proposal and upon checking of the documentary requirements, GILCOR PRINTING PRESS and LARAWAN STUDIO OFFSET PRESS were declared "**eligible**" to participate in the bidding and thus rated as "**passed**" while AG3 COLORS PRINTING PRESS was "disqualified";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **GILCOR PRINTING PRESS** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **GILCOR PRINTING PRESS** as the Lowest Calculated and Responsive Bidder with a bid amounting to **ONE HUNDRED THIRTY-EIGHT THOUSAND PESOS ONLY (Php 138,000.00)** for the provision of printing and delivery of wall calendar with metal hanger hook;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
