

# CONTRACT AGREEMENT

THIS AGREEMENT, made this      of      OCT 09 2023 between **Agricultural Training Institute - Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called "the Entity") of the one part and **Lamac Multipurpose Cooperative** of Mohon, Colonia, Tuburan, Cebu, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF FOOD AND ACCOMMODATION FOR THE TRAINING ON PLANT NURSERY ESTABLISHMENT MANAGEMENT AND ACCREDITATION FOR COCONUT, CACAO AND COFFEE BATCH 2** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Eleven Thousand Eight Hundred Fifty Pesos Only (Php 111,850.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Eleven Thousand Eight Hundred Fifty Pesos Only (Php 111,850.00)** or such other sums as may be ascertained, **Lamac Multipurpose Cooperative** agrees to **PROVISION OF FOOD AND ACCOMMODATION FOR THE TRAINING ON PLANT NURSERY ESTABLISHMENT MANAGEMENT AND ACCREDITATION FOR COCONUT,**

4. The **Agricultural Training Institute – Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

**AFFIDAVIT**

I, MONETTE T. TUMULAK, of legal age, Filipino, and residing at Tuburan, Cebu, after having been duly sworn in accordance with law, do hereby depose and state that:

1. I am Resort's Manager of Lamac Multipurpose Cooperative with office address at Mohon, Colonia, Tuburan, Cebu;
2. As the Resort's Manager of Lamac Multipurpose Cooperative, I have full power and authority to do, execute and perform all acts necessary to represent it in the bidding for PROVISION OF FOOD AND ACCOMMODATION FOR THE TRAINING ON PLANT NURSERY ESTABLISHMENT MANAGEMENT AND ACCREDITATION FOR COCONUT, CACAO AND COFFEE BATCH 2;
3.
