MAINTENANCE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This agreement is made and entered into by and between:

AGRICULTURAL TRAINING INSTITUTE-7, a National Government Agency whose office is located at Cabawan District, City of Tagbilaran, represented in this act by the Center Director, **GRACIA F. ARADO, Ph.D.**, Filipino, of legal age, married and residing at Poblacion, Corella, Bohol, and hereinafter referred to as the **CLIENT**.

-and-

PJS REFRIGERATION & AIRCONDITIONING SHOP, an establishment also existing in accordance with the laws of the Philippines, with office address at 0075 Espuelas St., Tagbilaran City, Bohol, and represented in this act by its Owner/Proprietor, **PANFILO E. SAMONTE**, Filipino, of legal age, married and residing at 75 Espuelas St., Tagbilaran City, Bohol, hereinafter referred to as the **CONTRACTOR**.

WITNESSETH

That the **CLIENT** is one of a reputable government agency in the City of Tagbilaran whose building and officers are air-conditioned with the following are conditioning units: Window type-10 units; wall mounted- 24 units; and floor mounted-2 units or the actual number of aircon units to be serviced;

That the **CONTRACTOR** represents itself as a capable and professional establishment possessing the required technical expertise to maintain and service its air conditioners it being the Authorized Dealer, Installer and Service Center in the City of Tagbilaran and the Province of Bohol;

That the **CONTRACTOR** offered its services and the **CLIENT** agrees to avail of the same under the terms and conditions stipulated hereunder;

NOW, THEREFORE, premises considered, the parties agree to the following terms and conditions:

- 1. The **CONTRACTOR** shall, under this Agreement, perform the following maintenance activities of the CLIENT's air conditioning units;
 - a. General cleaning and check-up every quarter;
 - b. Supervised all trouble calls;
 - c. On-site check-up and repairs.
- 2. For and in consideration of the above-cited activities, the **CLIENT** shall pay the **CONTRACTOR** a total of **FIFTY-FOUR THOUSAND TWO HUNDRED PESOS ONLY** (**) **54,200.00)** (as itemized below), exclusive of VAT Charges, and payable to **PJS REFRIGERATION & AIRCONDITIONING SHOP** as stipulated in the billing statement;

 The CONTRACTOR shall assign competent and highly skilled technicians/engineers who shall attend the preventive and/or corrective maintenance requirements of the CLIENT's air conditioning units;





preventive or corrective maintenance services, shall maintain cleanliness and orderliness in the CLIENT's officers and shall obligate themselves to report to the CLIENT or its representative (including guards on duty) any usual conditions of the air conditioning units during servicing and or maintenance check-ups of the air conditioning units;

- 5. The CONTRACTOR shall maintain specific manpower who shall undertake the preventive and or corrective maintenance servicing of the air conditioning units. The CLIENT, if it finds to be in their best interest, can request the CONTRACTOR to replace any "misbehaving" technicians;
- 6. The CONTRACTOR shall not be held liable for any losses or damages to the CLIENT's property due to fortuitous events or events beyond human control except those losses or damages incurred in the performance of the maintenance services through negligence, dishonesty, and inefficiency of the CONTRACTOR's personnel;
- 7. The CONTRACTOR shall be held responsible for taking disciplinary actions with respect to their personnel as may be necessary;
- 8. Consumables such as refrigerant gas, oil, welding materials, rewinding materials, insulation, copper tubes, specialty chemicals, if any, spare parts used to replace defective items, and other materials used in repairing the defective airconditioning unit/s, shall be charged to the count of the CLIENT;
- 9. For extra services, should the CLIENT for its own reasons, require extra services, the CONTRACTOR, for such additional services, shall charge an amount mutually agreed upon;
- 10. The assigned technicians shall remain the employees of the CONTRACTOR who shall be responsible for the salaries and accompanying benefits thereto;
- 11. In the event of injury/death of a person, either the assigned technicians or to other persons and/or damage to property arising from the work performed by the CONTRACTOR pursuant to this CONTRACT, the same shall be the responsibility and liability of the CONTRACTOR and the CONTRACTOR shall hold the CLIENT free and harmless from any such claims for death or injury;
- 12. Nothing herein shall be construed as creating an employer-employee relationship between the parties, between the CLIENT and the Assigned Technicians, it being expressly understood and acknowledge that of an independent contractor. Furthermore, the CONTRACTOR shall hold the CLIENT free and harmless from any claim or suit for unpaid wages, salaries, or benefits due its employees or laborers assigned to work specified in this CONTRACT;
- 13. CONTRACTOR warrants CLIENT that the services shall be performed in a good and workmanlike manner and shall be in accordance with the industry's standards. Any work rejected by CLIENT pursuant to this Contract shall be promptly repaired or replaced, as appropriate, by the CONTRACTOR at CONTRACTOR's sole coast and expense;
- 14. This CONTRACT shall cover the 3RD and 4th quarter period to commence on **September 1**, **2023**, **to December 31**, **2023** renewable depending on the CONTRACTORS performance evaluation result;
- 15. Should there be a breach or violation of any condition herein set forth, the offended party can effect pre-termination of this Contract upon issuance of a written notice offending party thirty (30) days in advance of the intended termination date. This provision is without prejudice to whatever rights and remedies the offended party may have against the offending party under applicable laws.
- 16. This contract shall be binding on the parties, their heirs, assigns, and successors-in-interest.
