BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY STAINLESS MUG FOR THE ADVOCACY MATERIALS FOR CFIDP ACTIVITIES/TRAININGS THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, ATI- RTC 7 requested quotation for the procurement of advocacy stainless mug for the advocacy materials for CFIDP activities/trainings in the amount allocation of **EIGHTY-TWO THOUSAND FIVE HUNDRED PESOS ONLY (P 82,500.00)**, dated October 2,2023 under PR No. 2023-10-804;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on October 4,2023 under PhilGEPS Ref.No. **10187314**, and ATI 7 website;

**WHEREAS**, in response to the said posting, 1. AVECILLA TRADING, 2. DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING 3. RC LUCKY GRAPHICS sent their quotations through its BAC Secretariat;

**WHEREAS**, the Bid Opening was held on 17 October 2023. During the opening of the bid proposal and upon checking of the documentary requirements, AVECILLA TRADING, DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING and RC LUCKY GRAPHICS were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that AVECILLA TRADING, the Lowest Calculated Bidder, is from Manila. It was indicated from the PhilGeps posting that the enduser prefers Bohol suppliers, this is to facilitate the delivery goods. Thus, the BAC did not accept AVECILLA TRADING's quotation.;

**WHEREAS**, the TWG conducted another careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184

and its Implementing Rules and Regulations to the second Lowest Calculated Bidder which is the **DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING**. It was found out by the TWG that the bid proposal/ quotation submitted by **DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING** has been found to be "Responsive";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

**NOW, THEREFORE, We,** the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING as the Lowest Calculated and Responsive Bidder with a bid amounting to SEVENTY-EIGHT THOUSAND PESOS ONLY (Php 78,000.00) for the procurement of advocacy stainless mug for the advocacy materials for CFIDP activities/trainings;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
