BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF RICE PADDY BOOTS FOR THE 10 BATCHES OF MODIFIED FARMER FIELD SCHOOL (FFS) ON THE PRODUCTION OF HIGH QUALITY INBRE RICE SEEDS AND FARM MECHANIZATION THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of Rice Paddy Boots for the 10 Batches of Modified Farmer Field School (FFS) on the Production of High Quality Inbre Rice Seeds and Farm Mechanization in the amount allocation of **TWO HUNDRED THOUSAND PESOS ONLY (P 200,000.00)**, dated September 11,2023 under PR No. 2023-09-735;

WHEREAS, in accrodance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on September 13,2022 under PhilGEPS Ref.No. **10124734**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING, 2. MAGADAN GENERAL MERCHANDISE sent their quotations through its BAC Secretariat:

WHEREAS, the Bid Opening was held on 20 September 2023. During the opening of the bid proposal and upon checking of the documentary requirements, DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING and MAGADAN GENERAL MERCHANDISE were declared "**eligible**" to participate in the bidding and thus rated as "**passed**" presented as follows:
