CONTRACT AGREEMENT

THIS AGREEMENT, made this 24th of october 2023 between Agricultural Training Institute - Regional Training Center VII of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called "the Entity") of the one part and Dalikyat Gentrade Supplies and Dry Goods Trading of Maria Clara St., Poblacion II, Tagbilaran City, Bohol, Philippines (hereinafter called "the Supplier") of the other part;

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of One Hundred Seventy-Eight Thousand Pesos Only (Php 178,000.00) or such other sums as may be ascertained, Dalikyat Gentrade Supplies and Dry Goods Trading agrees to PROCUREMENT OF RICE PADDY BOOTS FOR THE 10 BATCHES OF MODIFIED FARMER FIELD SCHOOL (FFS) ON THE PRODUCTION OF HIGH QUALITY INBRE RICE SEEDS AND FARM MECHANIZATION in accordance with his/her/its Bid.
