Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **One Hundred Thousand Pesos Only (Php 100,000.00)** or such other sums as may be ascertained, **Crissander Enterprises** agrees to **PROCUREMENT OF CUSTOMIZED BAMBOO NOTEBOOK AND BALLPEN SET WITH ENGRAVED LOGO FOR PRODUCTION OF CFITF ADVOCACY MATERIALS** in accordance with his/her/its Bid.
