BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF EASTLAND HOTEL AND RESIDENCES OF SUGBU REALTY INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF THE FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE TRAINING COURSE ON SEED TESTING FOR SEED ANALYSTS THROUGH ALTERNATIVE MODE OF PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 36 and Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS,** Section 36. A Single Calculated and Responsive Bid (SCRB) or a Single Rated and Responsive Bid (SRRB) shall be considered for award if it falls under any of the following circumstances:

- a) If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;
- b) If after advertisement, more than one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or
- c) If after the eligibility check, more than one bidder meets the eligibility requirements, but only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

In all instances, the Procuring Entity shall ensure that the ABC reflects the most advantageous prevailing price for the Government.

WHEREAS, ATI- RTC 7 requested quotation for the procurement of food, accommodation and venue rental with an Approved Budget for the Contracts (ABC) of ONE HUNDRED THOUSAND PESOS ONLY (Php 150,000.00) in accordance with its PPMP, dated February 26, 2024 under PR No. 2024-02-149;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published by the Bids and Awards Committee Secretariat to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders (preferably within Bohol Province) on February 27, 2024 under PhilGEPS Ref. No 1059-8202 and ATI 7 website, reposted under Bid Supplement No. 1059-8202 -01 on March 6, 2024;

**WHEREAS**, in response to the said reposting, EASTLAND HOTEL AND RESIDENCES OF SUGBU REALTY INC. submitted their quotations, through the BAC Secretariat;

WHEREAS, the Bid Opening was held on March 11, 2024. During the opening of the bid proposal and upon checking of the documentary requirements, EASTLAND HOTEL AND RESIDENCES OF SUGBU REALTY INC. was declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
