BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF RC LUCKY GRAPHICS AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY SHIRT FOR THE 4 BATCHES OF CFIDP INFORMATION CARAVAN (BOHOL AND CEBU) THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, ATI- RTC 7 requested quotation for the Procurement of advocacy shirt for the 4 Batches of CFIDP Information Caravan (Bohol and Cebu) in the amount allocation of **SEVENTY-TWO THOUSAND PESOS ONLY (P 72,000.00)**, dated February 12,2024 under PR No. 2024-02-120;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on February 17,2024 under PhilGEPS Ref.No. **10566943**, and ATI 7 website;

**WHEREAS**, in response to the said posting, 1. RC LUCKY GRAPHICS, 2. SEAWEED INTERNATIONAL EXPORTS INCORPORATED sent their quotations through its BAC Secretariat;

**WHEREAS**, the Bid Opening was held on 21 February 2024. During the opening of the bid proposal and upon checking of the documentary requirements, RC LUCKY GRAPHICS and SEAWEED INTERNATIONAL EXPORTS INCORPORATED were declared "**eligible**" to participate in the bidding and thus rated as "**passed**" presented as follows:

**WHEREAS**, the BAC further evaluated the aforementioned bid proposals/ quotations and agreed to perform a non-discretionary and non-discriminatory method of tie-breaking between the Lowest Calculated and Responsive Bidders in accordance with the GPPB Circular No. 06-2005, dated August 5, 2005, Guidelines on the Use of Non-Discretionary/ Non-Discriminatory Selection Criteria as Tie-Breaking Method incase of Two or More Bidders are Determined and Declared as

- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
