BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF SANDUGO PRESS MARKETING AND SUPPLIES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF OFFICE AND TRAINING SUPPLIES FOR RCEF TRAININGS FOR JANUARY TO DECEMBER 2024 THROUGH ALTERNATIVE MODE OF PROCUREMENT - SHOPPING (Section 52.1 (b) of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement Office and Training Supplies for RCEF trainings for January to December 2024 with an Approved Budget for the Contracts (ABC) of NINETY-NINE THOUSAND NINE HUNDRED EIGHTY PESOS ONLY (Php 99,980.00) in accordance with its PPMP, dated February 14, 2024 under PR No. 2024-02-079;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published by the Bids and Awards Committee Secretariat to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on February 16, 2024 under PhilGEPS Ref. No 1056-3757 and ATI 7 website, reposted under Bid Supplement No. 1056-3757-01 & 1056-3757-02;

**WHEREAS**, in response to the said invitation, there were three (3) bidders who have sent their quotations, namely: 1. DALIKYAT GENTRADE AND DRYGOODS TRADING, 2. DYNAMIC GENERAL MERCHANDISE, 3. SANDUGO PRESS MARKETING AND SUPPLIES:

WHEREAS, the Bid Opening was held on March 1, 2024. During the opening of the bid proposal and upon checking of the documentary requirements, DALIKYAT GENTRADE AND DRYGOODS TRADING, DYNAMIC CNG TRADING, and SANDUGO PRESS MARKETING AND SUPPLIES were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations The bid proposal submitted by SANDUGO PRESS MARKETING AND SUPPLIES has been found to be "Responsive";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared SANDUGO PRESS MARKETING AND SUPPLIES as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

- (a) Declare the SANDUGO PRESS MARKETING AND SUPPLIES as the Lowest Calculated and Responsive Bidder with a bid amounting to Eighty-nine thousand nine hundred sixty-five pesos only (Php 89,965.00) for procurement Office and Training Supplies for RCEF trainings for January to December 2024;
- (b) Recommend Alternative Mode of Procurement through Shopping as provided in Sec. 52.1 (b) and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
